Show Particulars:

You must be a current member of the NACA.

All animals must be registered or registrations pending at the NACA office.

Please allow sufficient time if you need an animal visually inspected (these close May 1st, 2022), along with registration paperwork sent to the office.

All Entries are due July 31st, 2022. Entries can be sent via mail, email, or text. Final results will be given at the NACA National Show Banquet at Gillette in September 2022.

Four pictures will be required (see attachment-same as required for a visual inspection) and a 30-40 second video.

All photos and videos will be uploaded to a virtual gallery, with public viewing as well.

When entries are received, you will be sent a confirmation.

Commercial Class Particulars:

You must be a current member of the NACA.

All entries must be native cattle, no M Branded cattle permitted. Can upload up to two videos of the entry being roped, along with the four photos.

2022 NACA VIRTUAL SHOW EXAMPLES OF PHOTOS TO SEND

We will be requesting the same photographs and videos that are needed to do a visual inspection of an animal.

You may take the photo with any camera you have available; the images below were taken from an iPhone.









Please also send a video along with the four pictures. The video, can be up to a minute in length, showing the animal from all sides within close proximity to the animal. All pictures and video can be sent to the above email or text.

Corriente Market Beef

The object of all market animals is to produce a carcass that results in the maximum amount of lean meat yield with a minimum amount of waste fat.

An ideal corriente beef animal is a combination of many factors. Market beef should be structurally sound. Conformation does play a part in corriente market beef, with an overall meat covering of the animal. The beef should be smooth and balanced from one end to the other.

From the side, the ideal animal should be free of extra leather in the neck and brisket area. The middle should be trim, with a clean long underline. The flank should not be excessively deep. Extra depth and excessive fullness to the flank is nothing but waste fat. The animal should have a thick strong muscular top and wide loin area. A short-coupled animal will result in excessive belly fat and waste. Look for a longer leaner animal, there will be less waste.

The ideal market steer or heifer should be:

- 1. A structurally sound animal.
- 2. Free of extra skin leather in the throat area, brisket and dunlap.
- 3. The middle should be trim, with a long clean underline.
- 4. The top line should be clean and long, with a wide loin area.
- 5. Extra depth and excessive fullness to the flank is nothing but waste fat.
- 6. All points of the animal should blend into the next part.
- 7. The peaked tail head should be filled in and blend into the loin area.
- Market or butcher weight will be up to the owner as some cattle develop and mature out quicker than others.
- Different regions of the country will have different aspects of the conformation guidelines.




Criteria for the Certified Corriente Beef Program


